President James Young called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Dr. Kyle Thompson took roll call. Trustees present were Bill Hill, Elizabeth Hubbert, Max Jones, Rick Manuell, Mark Wascher and James Young. Anne Pool was absent. Visitors present were petitioners Dustin and Jody Will, Dieterich CUSD #30 Superintendent Cary Jackson, Alan Zuber and Sarah Hubbert.

James Young asked members for any comments or corrections on the minutes from the October 3, 2016 meeting. None noted. Bill Hill made a motion to accept the minutes. Elizabeth Hubbert seconded. Motion carried. There was no public comment.

Dr. Mattingly announced Trustees Bill Hill and Rick Manuell were re-elected to serve six year terms and Mark Wascher was re-elected to complete a two year term on the Regional Board of School Trustees for ROE 11. Edgar County did not have a candidate, thus creating a vacancy.


Bill Hill made a motion to adjourn the meeting. Mark Wascher seconded the motion. Motion carried. Meeting adjourned at 7:03 p.m. Sine Die.

At 7:03 p.m., Dr. Mattingly convened an organizational meeting as her duty as ex-officio secretary of the board. She called the meeting to order and had Dr. Thompson take roll call. Members present were Bill Hill, Elizabeth Hubbert, Max Jones, Rick Manuell, Mark Wascher and James Young. Others present were Assistant Regional Superintendent Dr. Kyle Thompson, ROE #11 staff Marla Leasher, Court Reporter Joyce Lawrence, Alan Zuber, petitioners Dustin and Jody Will, Dieterich CUSD #30 Superintendent Cary Jackson, and Sarah Hubbert.


Dr. Mattingly introduced Alan Zuber from Paris, Illinois in Edgar County. Elizabeth Hubbert made a motion to nominate Mr. Zuber to fill the vacancy on the RBST. Bill Hill seconded. Motion carried. Mattingly administered the Oath of Office to the newly elected/appointed board members. Manuell, Hill, Wascher and Zuber signed and returned their oaths to Dr. Thompson. Bobbi asked for presidential nomination. Dr. Hill nominated James Young. Rick Manuell seconded the motion. Roll call vote ended in 7-0 vote in favor of James Young. Young will serve as president for the next two years.

Additional business at hand was to act upon a detachment/annexation hearing filed by Dustin and Jody Will. The petition was granted on a vote of 7 yes, 0 no. The transcripts from the hearing are filed at the office of the Regional Superintendent of Schools, 730 Seventh Street in Charleston.

Elizabeth Hubbert made a motion to adjourn the meeting. Mark Wascher seconded the motion. Motion carried. The meeting was adjourned at 7:55 p.m.
