Elizabeth Hubbert made a motion to accept the minutes from the April 9, 2018 meeting. Alan Zuber seconded. Motion carried.



The Petition requested the detachment of certain property from Charleston CUSD #1 and annex same property to Mattoon CUSD #2. 
The Petitioners presented evidence in support of their petition.
