Dr. William Hill made a motion to appoint Lis White as President Pro Tem in the absence of RBST Board President James Young. Mark Wascher seconded. Motion carried.

Max Jones joined the meeting at 5:04 p.m.

Dr. William Hill made a motion to accept the minutes from the August 9, 2022 meeting. Rick Manuell seconded. Motion carried.


The Detachment/Annexation Petition submitted to the Regional Board of School Trustees by Edward Schumacher and Dean Bloemer and Jeremy E. Schumacher and Beth A. Schumacher was presented. The Petition requested the detachment of certain property from Neoga CUSD #3 and annex same to Teutopolis CUSD #50. Testimony from Attorney Kyle Boose was heard. Testimony from Jeremy Schumacher was heard. Testimony from Keith Deters was heard. President Pro Tem Lis White opened the Hearing to public comment and closing statements. Rick Manuell made a motion to adjourn into closed session. Max Jones seconded. Motion carried. The Regional Board of School Trustees entered closed session at 5:30 p.m. The Regional Board of School Trustees returned from closed session at 5:46 p.m. A motion to recess was made at 5:47 p.m. by Rick Manuell. Lis White seconded. Motion carried. RBST recessed at 5:47 p.m. Dr. William Hill made a motion to reconvene. Mark Wascher seconded. Motion carried. RBST reconvened at 5:50 p.m. Dr. William Hill made a motion to vote to approve the petition. Mark Wascher seconded. Motion carried. A roll call vote was taken that resulted in 4 votes in the affirmative to grant the Petition and 1 vote to deny the Petition. The Petition was granted.
