The Detachment/Annexation Petition submitted to the Regional Board of School Trustees by Joseph and Lyndsay Tharp and Joanna Cellone was presented. The Petition requested the detachment of certain property from Oakland Unit School District #5 and annex same to Shiloh CUSD #1. At 4:35 p.m. RBST Member Max Jones joined the meeting. Testimony from Joseph and Lyndsay Tharp was heard. Testimony from Shiloh CUSD #1 Superintendent Bill Myers was heard. RBST President James Young opened the Hearing to public comment and closing statements. There were none. Dr. William Hill made a motion to discuss and proceed with a vote. Mark Wascher seconded. Motion carried. A roll call vote was taken that resulted in 7 votes in the affirmative to grant the Petition and 0 vote to deny the Petition. The Petition was granted. Dr. William Hill made a motion to adjourn the meeting. Rick Manuell seconded the motion. Motion carried. The meeting was adjourned at 4:54 p.m. A complete transcript of the Hearing was recorded by Erika Kessler, Certified Reporter. Dr. Thompson shared the election results, no new members.




