




Transportation

District Policy and McKinney-Vento Eligible Students

For transportation that is not to the school of origin, local educational agencies are required to provide transportation that is comparable to that provided to housed students. 42 USC 11432(g)(4)(A). Therefore, the same policy on walk zones would apply to McKinney-Vento students. However, the McKinney-Vento Act also requires LEAs to eliminate barriers to the school enrollment and retention of students experiencing homelessness. 42 USC 11432(g)(1)(I), (g)(7). So if there is something about this particular family's homelessness that is a barrier to walking to school within the 1.5 miles, then the school district would be required to eliminate the barrier, potentially through transportation, depending on the exact situation. That might mean providing a bus or a taxi; gas voucher, bicycle (as long as it is safe and appropriate); providing a crossing guard or helping create a walking group for safety.
