## **II. Approval of September 7, 2022 Meeting Minutes**

## **V. Fall Professional Development Newsletter 2023**

The Fall 2023 Professional Development newsletter has been emailed to all school districts whom have provided an updated directory. Katie highlighted a few of the upcoming opportunities. The board was reminded to continue to visit the ROE website for events that are scheduled after the newsletter was published. She also mentioned the ROE had purchased a new digital star lab that they would be rolling out this fall.

## **VI. ROE #11 Fall Institute**

The 2022 fall institute was a huge success. At this time, the ROE will be offering a regional institute every other year. The event will tentatively run from 8:30 am to 1:00 pm and each site will hear an opening and closing keynote. Feedback from last year's session indicated that educators enjoyed the keynote but wished they could have heard both messages. Between the opening and closing keynotes there will be two breakout sessions. Katie asked the board to encourage their colleagues to present at a breakout session.

## **VII. RSAC Scholarship**

ROE #11 is once again offering a scholarship opportunity to school districts wishing to send a team of educators to the Raising Student Achievement Conference that will be held in Oakbrook on December 11<sup>th</sup> and 12<sup>th</sup>. The scholarship will reimburse school districts for up to two early bird registration fees. Applications for the scholarship are due to ROE #11 by Friday, September 15<sup>th</sup>.

## **VIII. Specific Learning Disability Support Project (SLD)**

The Specific Learning Disability Support Project is a federally funded grant project through ISBE in partnership with EIU and EIASE. Their project offers training and resources to meet the educational needs of all students with specific learning disabilities and aims to increase reading and math skills. ROE #11 recently met with the SLD team and will be scheduling opportunities for general education and special education teachers on reading, writing, and math.

## **IX. Licensure Updates**

Katie shared that ISBE is still planning to roll out PD + in 2025. The goal of PD + will be provide a one-stop shop for educators to search for and register for professional development offered through ISBE-approved professional development providers. The system will also track the completion of PD hours for educators, eliminating the need for manual entry by individual educators.

She also shared that educators can continue to rollover unused professional development hours completed between April 1<sup>st</sup> and June 30<sup>th</sup> of the final year of their renewal cycle to the next five year renewal cycle.

Lastly, ISBE did renew the short term substitute license. Anyone with an associate's degree or 60 credit hours can obtain this license. This is valid for grades PK-12 and will be valid until June 30, 2029. At this time, someone with this license cannot teach for more than 5 consecutive days per licensed teacher. However, there is current legislation to change that to 10 consecutive days.

## **X. ROE #11 Local Wellness Policy**

The ROE #11 Local Wellness Policy was reviewed by the board and it was unanimously approved.
